- Assess and treat elective and urgent consultations.
- Assess and treat patients in accordance with best practice standards and all applicable regulatory standards.
- Provide evidence-informed medical and/or interventional pain management to patients based on appropriate clinical indication and meet high standards of care.
- Utilize fluoroscopy or ultrasound to perform most interventions.
- Participate in collaborative care with Paramedical clinicians and other physicians and support the services available for multidisciplinary interventional pain management.
- Report regularly to the Medical Director and work closely with the Clinic Manager, Executive Team and Patient Access Team.
- Maintain continued professional development, at a minimum as required by the provincial regulatory body.
- Participate in team meetings, educational events and clinic social events.
- Complete medical documentation and visit claims data in the clinic's electronic medical record (EMR) system in a timely and professional manner.

#### OTHER:

• Other duties based on need, including teaching, research, educational presentations, expert opinion report preparation, independent medicolegal consulting, and administrative tasks.
