



## **Assistant or Associate Professor (Clinical), Department of Anesthesia, Pediatric Cardiac Anesthetist**

### **Position description**

The Department of Anesthesia of McGill University and the McGill University Health Centre (MUHC) invite applications for a full-time Pediatric Cardiac Anesthetist at the Montreal Children's Hospital. The successful applicant will hold an academic appointment at the rank of Assistant or Associate Professor (Clinical), as a member of the Contract Academic Staff. The rank will be determined according to the candidate's qualifications and experience. This position does not confer eligibility for tenure.

### **Job Duties**

The successful applicant will provide anesthesia care and academic leadership in research and education at the MUHC, with a focus on pediatric cardiac anesthesia. The candidate will join a group of 18 clinical pediatric anesthetists at the MUHC Department of Pediatric Anesthesia. The position involves teaching fellows, residents, and medical students, and participation in research activities and the education program provided by the McGill Department of Anesthesia and the Faculty of Medicine and Health Sciences.

It is expected that the successful applicant will contribute to the pediatric cardiac anesthesia on-call service. Previous experience in pediatric intensive care as staff is essential to provide optimal care to these patients.

McGill faculty members are expected to contribute to service activities within their units, the University, and the wider scholarly community. The successful applicant must demonstrate a commitment to equity, diversity and inclusion in these activities.

## Qualifications and Education Requirements

Candidates must have an MD degree and demonstrate expertise in Pediatric Cardiac Anesthesia. They must hold or be eligible for licensure in the province of Quebec. Royal College of Physicians and Surgeons Fellowship or equivalent is also expected. A PhD in anesthesia or physiology and publications of original work in high impact medical journals would be strong assets and desirable in order to support the academic mission. All candidates must fulfil the language requirements of the *Office québécois de la langue française* (OQLF).
